# BACKGROUND:

Groundbreaking is expected to commence in Fall 2024 and the new School of Nursing Building is scheduled to open in August 2026. It will be located on South Campus near the School of Fine Arts. The new building's design, its programs, curricula, learning and innovation spaces, and new technologies, are expected to prepare UConn nursing graduates to be leaders and change-makers in the field. The proposed undertaking is expected to yield a four-story building, approximately 70,000-80,000 square feet (sq. ft.) in size.

Douglas Casa is director of the University of Connecticut's Korey Stringer Institute, named for the Minnesota Vikings lineman who died of heatstroke in training camp in 2001. He's been researching athletes and exertional heatstroke for some three decades. "I can't guarantee everything that is going to happen in the future," Casa said. "But based on over 3,000 cases we've tracked, if someone's temp gets under 104 within 30 minutes of the presentation of heatstroke, no one has ever died."

Dr. Rigoberto A. Lopez is an economics professor at the University of Connecticut who says these practices tend to affect lower income communities disproportionately because many dollar stores tend to be located in these communities. Lopez calls it a predatory practice because he says many of these communities where dollar stores are located tend not to have easy access to banks or other options for withdrawing a consumer's cash.

"The poor are paying more for their own cash," Lopez said. "Basically what it amounts to is a predatory practice."
