The Board of Trustees meeting was called to order at 9:47 a.m. by Vice-Chair Andrea Dennis-LaVigne, who opened and chaired the meeting on behalf of Board Chair Toscano. Board Chair Toscano assumed chairing the meeting at the start of Chairman's Report.

## 2. Chairman's Report

### (a) Matters Outstanding

Board Chair Toscano acknowledged the University's annual Undergraduate First Destination survey results, which gathers data about recent graduates. He noted that approximately 91% of UConn's most recent alums have reported positive post-graduation outcomes. In addition, a larger percentage of in-state students and a greater number of out-of-state students have remained in Connecticut compared to last year's data.

Board Chair Toscano highlighted the results of a multi-year analysis by UConn's researchers from the Outage Prediction Modeling team that tracks intense weather events affecting power grids across the country.

Board Chair Toscano recognized Dr. Jeffrey Hines, Vice President of the Office for Inclusion and Civil Rights at UConn and UConn Health, who delivered the keynote address at the Connecticut Martin Luther King, Jr. Holiday Commission Commemoration at the State Capitol.

Lastly, Board Chair Toscano congratulated former student-athlete Tage Thompson and the USA men's ice hockey team for the first gold medal since 1980.
